#### **ICN Chairman's Comment**

I would like to congratulate the ICN team on a busy 2010 that included some significant outcomes for local industry and a number of exciting new initiatives. These achievements include:

**Orders for local industry** ICN helped secure \$255M in orders for Victorian industry during the 09/10 year – reaching a total of over \$2 billion since the organisation was established in 1984.

Four new Victorian offices ICN has added to its network of five regional Victorian offices with representatives now also based at the Victorian Business Centres in Dandenong, Bundoora, Sunshine and

**New international office** ICN has opened an ASEAN regional office to be based at the Victorian Government Business Office in Kuala Lumpur targeting business opportunities across the region.

Increasing SMEs' Access to Major Projects ICN continues to assist SMEs access major projects across Victoria and has consultants allocated to help identify local suppliers for the State's Strategic Projects where local content has been mandated.

Increasing access to international markets ICN has actively targeted opportunities for Australian companies in China, India and Latin America, including the Delhi 2010 Commonwealth Games where Australian companies were awarded more than \$84M in orders.

**Australian Urban Systems (AUS)** ICN is now coordinating AUS, promoting Victoria's sustainable urban development sector into international markets.

**Regional Industry Link** RIL was expanded state-wide across Victoria and has helped match registered businesses to \$150M of contracts.

**VIPP** Since 1 July 2009, over 3,000 tenders have been evaluated by the ICN VIPP team. The policy has led to \$334 million of orders for local industry.

For over 26 years ICN has supported Australian industry by introducing buyers to competitive local suppliers of the goods and services they require. The financial support of the Victorian Government is fundamental to ICN's success in this role.

We welcome the Coalition Government and The Honourable Richard Dalla-Riva MLC, Minister for Manufacturing, Export and Trade, and look forward to a continued successful partnership into the future for the purpose of strengthening Victorian industry through import replacement, local sourcing and exports.

#### \$84 million Win for Australian Companies at the Delhi 2010 Commonwealth Games

Australian companies played a major role delivering the Delhi 2010 Commonwealth Games, beating world-wide competition to win more than \$84 million in contracts supplying goods and services including architecture and design, catering, consultancy and advisory services, pyrotechnics, the baton relay, synthetic turf technology and stadium roofing.

The companies secured the contracts with the support of ICN, together with Austrade, the Australian Government and the state governments of Victoria, New South Wales and Queensland.

The Australian Government's Supplier Access to Major Projects (SAMP) program enabled ICN to engage Austrade's locally-based representative Amarbir Anand. Amar identified suitable opportunities for Australian companies and supported several trade missions to the region providing participants with the opportunity to showcase their capability and establish valuable contacts.

With the continued support of the SAMP program, ICN is maintaining its focus on export opportunities with international sporting events, targeting opportunities with the Rio 2016 Olympic Games and 2014 Brazil Football World Cup.

The project is being delivered by the


Sunbury Electrification Alliance and will include station upgrades, additional stabling, more park and ride spaces and alterations to the existing safe-working systems.
